#### Minutes

Approve April minutes – **motion** to approve as amended by Jana Tindall seconded by Alan Taylor. Motion carried unanimously.

## President's Report—Brenda Bye

Signup Genius discussion: The discussion noted that different signup accounts are used for the help desk and the farmers market, potentially leading to confusion. Brenda is currently administering the farmers market signups using the BCMGA account. Laurie Gibson is administering the help desk using the OSU account. Otillia noted that both signups are probably under the purview of extension, but the current staffing level creates difficulties. Brenda noted several advantages with BCMGA handling the signup and said she is happy to continue administering the farmers market account. The issue was tabled until additional extension staff has been hired.

Financial report presented and reviewed.

**Motion** made by Paula to preapprove the rollover of the FIB (5212) 6/15/24 CD. Marge seconded—motion carried unanimously.

### Plant Sale Revenue:

Approximate gross income from the 2024 plant sale was \$49K. The 2023 gross income from the plant sale was \$8000 more, at \$67K. The difference is attributed to fewer plants for sale. No dig and divides were held this year, although we did have some plants from the last year's dig and divide. Additionally, some plants were not ready to sell because of the colder weather.

### Desk Training Update—Alan Taylor

Otillia is providing an updated list of trainees that have completed their course work and are eligible to sign up for desk training. The first training was held last Thursday (May 9). They will be receiving two training sessions. Many of this year's trainees have weekday jobs and need more weekend or evening opportunities. Otillia said she would be making cold calls to companies and organizations to see if they are interested in hosting clinics. She will provide Brenda the names of those who have expressed interest. Brenda is working on additional farmers market clinic tables. Currently, not many trainees are signed up and there are lots of unfilled shifts. Jill suggested that Certified Master Gardeners that are not interested in training but would like to work the desk be given a process in which they can sign up for upcoming and unoccupied shifts. All agreed it was a great idea! Alan will draft an invitation with details for the next President's email, as well as a note to encourage trainees to sign up.

Ask Extension was brought up as a possible venue for earning direct hours toward certification for those trainees who can't work during the week. The general consensus was that more information about Ask Extension was needed. Otillia will research and provide information prior to the next board meeting.

# Extension Report—Otillia Schreuder

- Otillia thanked BCMGA's desk refresher training team.
- We have a new supplier of badges with a faster turnaround time.
- Twenty Two MGs attended a Master Gardener Continuing Education event held May 9<sup>th</sup> in Tangent. The topic was invasive species, noxious weeds, pesticides and other relevant topics for Master Gardeners. More CE events are in the works.

Trainee Update—Otillia Schreuder.

Otillia is clearing trainees today to begin desk training, which will be followed by rolling approvals based on completed course work. The majority of trainees have an ECCO account.

#### Good of the Association

Association Badges: Paula would like to pursue the purchase of badges for the BCMGA associate members. The badge would need to be different enough so that they are not mistaken for Certified MGs. All present liked the idea. Paula will research and bring a formal proposal at the next board meeting.

Spirit of Gardening Poles: Brenda is currently recruiting for a lead to design and create a spirit pole to support the Joy of Gardening silent auction. Each BCMGA chapter is encouraged to provide a garden art pole designed to represent their county. Brenda asked how this should be funded. Paula said it should be drawn from the budget discretionary fund.

Efforts to find land for greenhouse: Kathy Clark and Paula met with Sam Angima (Associate dean for Extension) and Leslie Madsen (Statewide Master Gardeners Program Manager) to solicit their support in finding an unused parcel within OSU to use as a propagation facility and educational greenhouse. Kathy is completing a two-page synopsis with details and will forward to Sam and Leslie. The goal is for them to support us in discussions with Mike Green (VP for Finance & Administration, Chief Financial Officer). Kathy has identified 3 or 4 possible parcels.

Judith Kenner and Laura Horsey are talking with a person with private land that might be usable.

Jana talked with someone with an unused parcel, but after visiting determined it was not large enough.
